FREE Online Training for NNADAP Workers

Six (6) online courses are offered for free by the Thunderbird Partnership Foundation (formerly the National Native Addictions Partnership Foundation) for NNADAP Workers. Courses include:

- ⇒ Supporting Collaboration of Western and Indigenous Cultural Practices
- ⇒ Training for Supervisors, Program Managers and Clinical Supervisors
- ⇒ Protocols for Indigenous Practitioners
- ⇒ Indicators to access Cultural Competency Along Honouring Our Strengths

Each course is certified by the Indigenous Certification Board of Canada (formerly the First Nations Wellness and Addictions Counsellor Certification Board) and the Canadian Council of Professional Certification (CCPC).

Addictions Management Information System

AMIS is the database used by NNADAP Treatment Centres to collect and track client information. It is a web-based database which collects evidence that can be used to inform client care, demonstrate the strengths of the treatment centres and to support research initiatives.

AMIS is being piloted for use by NNADAP Community-Based Workers. It has a referral function which allows community-based workers to refer clients to appropriate treatment centres by completing the referral online through AMIS. Part of the referral includes completion of the Drug Use Screening Inventory (DUSI), which is a helpful assessment tool for identifying client needs and developing appropriate programming for clients. The version of DUSI used by AMIS is culturally relevant to the particular needs of First Nation clients.

We are expecting it to be available for use by all community-based NNADAP workers in 2016.
